

**LA'IE CEMETERY**  
**PART I**  
**BURIAL AGREEMENT**

The following are the burial terms and conditions, grave plot prices and burial fees for the La'ie Cemetery, La'ie, O'ahu, Hawaii:

1. Cash (or equivalent) payment in full and all documentation must be completed a minimum of three (3) days prior to the date of the burial.
2. There will be no refunds on plot sales.
3. Vaults are required to preserve the structural integrity of the gravesite and to prevent encroachment of collapsing grave walls into adjacent plots. You must purchase the vault from La'ie Cemetery (see Cemetery and Burial Fees Schedule, Part II). Homemade vaults are not allowed for health, safety and liability reasons.
4. The funeral procession must be at the cemetery at \_\_\_\_\_ am / pm and must leave the gravesite by \_\_\_\_\_ am / pm. The Responsible Party will be assessed \$100 for each hour that extends beyond this time. The overtime deposit will be applied against overtime charges. If applicable, the overtime deposit fee will be refunded, by mail, to the Responsible Party.
5. The funeral procession must vacate the gravesite prior to the closing of the grave. The gravesite will not be closed until the site has been vacated by the funeral procession. However the funeral procession may return to the gravesite once the site has been completely closed.
6. Hawaii Reserves, Inc., its assigns, agents or successors, assumes no responsibility or liability for any improvements made to the grave, including, not limited to, headstones.
7. The Responsible Party must notify the HRI office, submit a plan for and receive approval, and schedule the time before any improvements (headstone, cement work, etc.) or renovations are made to the gravesite. You are to ensure that any cement work, including the headstone, is to be kept within the designated plot area. If any part of the improvement extends into an adjacent plot, it may be moved or removed by Hawaii Reserves, Inc., at its discretion, and without any notice to you. You will be billed for the cost of the removal or adjustment. If any adjacent plot is not usable as a result of your cement work, you will be required to pay for the unusable plot(s).
8. This is not a "perpetual care" cemetery.
